During 2011 the Humane Society placed 1,320 animals into permanent homes. Of the animals placed, many had been transferred to the Humane Society by other animal welfare agencies throughout the region. Virtually all the animals transferred in were scheduled for euthanasia and would likely have died without the services of the Humane Society.

4b (Code:) (Expenses \$ 205,305. including grants of \$) (Revenue \$)

During 2011 the Humane Society provided medical care to many dogs and cats during the time the animals were under the Humane Society's care. These services included basic vaccinations, general worming, microchip implants, urgent care, minor surgeries, and other necessary procedures to improve the pet's health during their time at the Humane Society. Additionally, 708 animals were spayed or neutered, preventing more unwanted animals from being born.

4c (Code:) (Expenses \$ 52,793. including grants of \$) (Revenue \$ 7,857.)

The Humane Society helped to change the lives of over 90 at-risk children through its innovative human and humane education program HELP. This program not only changes the lives of children in numerous ways, it also trains unruly and untrained dogs temporarily living at the Humane Society to help them find homes more quickly. Additionally, 1500 students learned about responsible pet care and respect for all living beings through the general humane education programs.
